School Policy

1. Overseas Students must pay fees in full in order to be eligible for acceptance. The Registration Fee and Tuition Fee must accompany the Application Form. The Registration Fee is non-refundable. Fees must be paid in full certified cheque, cash or bank draft only and should be made payable to:

2. Upon receipt of full payment of Tuition Fee and Registration Fee, a Letter of Acceptance and Receipt will be issued.

Refund Policy

1. Once the student has been accepted by the school and paid Tuition Fees in full, there will be no refund except under the following condition:
When a student is unable to obtain a valid student visa to enter Canada, the said student will receive a full refund of tuition fees. The Registration Fee (\$200) is not refundable.
2. In order to be eligible for a refund, the student must provide the following:
 - I. A letter in writing requesting a refund, signed by the student
 - II. Proof of a visa rejection issued by the Canadian Embassy or High Commission
 - III. All the original document including all receipts issued by the school
3. If a student is granted a student visa and decides not to study at our school, there will be no tuition refunds under any conditions.
4. There will be no refund under any conditions if the student's visa application is refused, and he/she does not apply for a refund within 8 months from the date when the student received refused letter.
